INDEPENDENT AUDITORS' REPORT

To the shareholders of Imereti Agro Zone LLC Report on the Audit of the Financial Statements

Modified Opinion

We have audited the financial statements of Imereti Agro Zone LLC (the Company) which comprise the statement of financial position as at 31, December 2020, and the statement of comprehensive income, statement of changes in equity and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, except for the effects of the matter described in the basis for modified opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Company as at 31 December, 2020 and its financial performance and its cash flows for the year then ended in accordance with International Financial Reporting Standards (IFRSs).

Basis for modified Opinion

The basis of our modified opinion is based on the fact that due to VAT exemption as of December 31, 2020, the company has a tax asset of GEL 361,914. In our opinion, there is risk of misstatement, as the exact scope of future activities and types of services to be provided by the company are not yet known, so it is possible that in the event of a tax audit of the company, this VAT issue will be the subject of future discussion.

We conducted our audit in accordance with International Standards on Auditing (ISAs). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Company in accordance with the International Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants (IESBA Code) together with the ethical requirements that are relevant to our audit of the financial statements in Georgia, and we have fulfilled our other ethical responsibilities in accordance with these requirements and the IESBA Code.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our modified opinion.

Management's responsibility for the financial statements
